be of the owner or occupier or association of such owners or occupiers of the building or premises and the fire fighting arrangement should be in workable condition round the clock.



**Sub: Advisory on discontinuation of renewal Fire Safety Certificate.**

In compliance with the provisions of the Assam Fire & Emergency Services Act, 2025 and the Assam Fire and Emergency Services (Amendment), Rules, 2025, the requirement for renewal Fire Safety Certificates for buildings/premises stands discontinued w.e.f. 24.12.2025.

2. Applicants whose Fire Safety Certificate expired before 24.12.2025 should be advised to apply afresh through the online portal. However, Fire Safety Certificates whose validity has expired on 24.12.2025 or is going to expire after 24.12.2025 shall deemed to be valid until it is cancelled by the Competent Authority.

3. A new system for submission of Self-Declaration by Owner/Occupier shall be introduced on the designated online portal by the NIC, shortly. Details of the same will be circulated to all in due course.
